By becoming a Supporter of Clean Up Mobile Phones, you agree to the following

- Promote 'Clean Up Mobile Phones' in a responsible manner, giving consideration to the objectives of the program and Clean Up Australia's overall objective of inspiring Australians to clean up, fix up and preserve the environment.
- Work in a manner consistent with local laws and regulations and endeavour to cooperate with any appropriate local authorities.
- Maintain the 'community spirit' of Clean Up Australia in any Supporter driven activity, including any collection of mobile phones.
- Display the 'Clean Up Mobile Phones' logo in all promotional material for the purpose of promoting the Clean Up Mobile Phones program at a local level, and restrict the use of the 'Clean Up Mobile Phones' logo to such material.
- Use of the 'Clean Up Mobile Phones' logo does not permit the Supporter under any circumstances to use the 'Clean Up Australia' or 'Clean Up the World' logo, nor indicate the organisation is in partnership with either of these entities.
- Follow the Clean Up Mobile Phones Collection Guidelines and return all collected phones to our program partner Aussie Recycling Program (ARP).
- The Supporter understands that it is responsible for all financial, indemnity and management matters relating to its promotion of 'Clean Up Mobile Phones' and relating to the collection of mobile phones whilst in the Supporter's possession, and that Clean Up Australia has no liability in any respect in relation to the Supporter's activities.
- The Supporter understands the registration fee and support offered applies for 12 months from the date of registration. Supporter will be given opportunity to renew registration at this time.
- Clean Up Australia may refer to the Supporter on the Clean Up Australia website and in Clean Up Australia publications.
- The Supporter understands that it is not a representative of Clean Up Australia and cannot make representations on its behalf without express written permission.
