LITTER REPORT FY24 QLD

During the financial year of 2024, Clean Up Australia volunteers continued to unite against litter by taking to their streets, beaches, parks, bushland and waterways to Clean Up.

While over a million joined us last year across 16,320 sites, the Litter Report FY24 is a snapshot of litter removed by Clean Up Australia volunteers across a portion of these sites during Clean Up Australia Day and Every Day Clean Ups. Across Queensland, the Report is based on the count of 78,252 litter items from 306 surveyed locations (91,609 items from 282 locations in FY23).

NOTABLE CHANGES

The order of the top six grouped items has changed from FY23 to FY24 with soft plastics moving to first position with an increase of 5.7%, with non-food packaging moving to second position with a decrease of 3.2%. Soft plastics in QLD are a problematic litter item, with reported levels 3.2% higher proportionally than the national average. It will be interesting to note whether soft plastics recycling triols which began in QLD in 2024 decrease soft plastic litter levels in future. Beverage containers moved from fourth to third position increasing by 2.4% and overtaking household Items.

All other items show minimal percentage changes over FY23.

NOTABLE CHANGES

In FY24 soft plastics are still the most reported item in OLD but show a decrease of 2%. Cigarette butts remain in second position in the individual items list with a small decrease of 0.9%. Of note we have seen a significant increase by 7.2% in the number of plastic bags reported, although light plastic bags with handles and thick plastic bags with handles are banned in OLD as of 2022 and 2023 respectively.

There has been a large decrease by 7.4% in plastic takeaway food containers reported and other single-use items such as cuttery, which was banned in QLD in 2021. Plastic straws have also seen a decrease which may reflect the phase out of straws in QLD since 2021.
